Practice Summary

Zack's practice focuses on housing, infrastructure, commercial development, and compulsory purchase work. He appears regularly in planning appeals at inquiries and hearings local plan examinations, compulsory purchase order inquiries and court hearings in the High Court, Court of Appeal and Supreme Court.

The directories rate him as "exceptionally talented", "an absolutely brilliant barrister" (Chambers and Partners), "in high demand" (Who's Who Legal), "a joy to work with", "fantastic", "one of the best planning barristers out there" (Legal 500), "mould-breaking", "a go-to person", "simply brilliant" and "a star advocate" (Planning Magazine). Zack has been nominated for the Environment and Planning Junior Barrister of the Year in the Chambers and Partners Bar Awards 2024, as well as for the Planning and Land Use Junior Barrister of the Year in the Legal 500 Bar Awards in both 2022 and 2024. He is a Tier 1 ranked "leading junior" in Legal 500.

Zack is an Honorary Associate Professor at the Bartlett School of Planning, UCL.

Planning

Zack acts for a wide range of developers, including some of the UK's leading housebuilders (including Barratt Developments, the Berkeley Group, Bellway, Redrow, Vistry, Persimmon, Taylor Wimpey, Cala Homes, Bloor Homes, the Peabody Trust, Places for People, Clarion, Keepmoat Homes, Galliard Homes, Croudace Homes, Thakeham Homes, Wain Homes, Jelson Homes and Lioncourt Homes), a wide range of regional housebuilders, national developers like Henry Boot, Wates and Tarmac, and some of the country's leading land promoters (including Catesby Estates, Richborough Estates, Gleeson Land, Gladman Estates, Rainier Developments, L&Q Estates, Tarmac, Axis Land Partnerships and IM Land), Central Government, and many local planning authorities.

Zack also acts for a wide range of institutional developers including schools, universities and NHS Trusts.

Some of the schemes Zack has recently acted on – in relation to the planning application, planning appeal, CPO and/or legal challenge stages – include:

- **Edith Summerskill House, Putney** – a 20 storey tower in South-West London designed by Henley Halebrown containing 133 homes, all of which will be affordable. Zack successfully promoted the scheme for a joint venture between Stanhope PLC and the LB Hammersmith and Fulham after a two-week call-in inquiry.
- **55 West, Ealing** – a 19 storey building by DMWR Architects which comprises 144 affordable homes (100%) and retail space next to the new West Ealing Elizabeth Line Crossrail station. Zack succeeded in an appeal for the developers – Southern Grove and Metropolitan Thames Valley Housing.
- **Bicester Ecotown** – Zack appeared at inquiry for the successful promoter of a scheme for 530 new homes in North West Bicester Ecotown. The Ecotown is the first of its kind in the UK.
- **The Green, Southall, Ealing** – Zack successfully promoted a scheme to redevelop and regenerate a strategic allocation in the heart of Southall for a scheme including 564 residential dwellings, along with flexible commercial and employment floorspace. Zack appeared for the Council and the Developer (the Peabody Trust) at the CPO inquiry.
- **Heythrop College, Kensington** – a scheme designed by John Bushell to redevelop a substantial site next to Kensington Square, including a state-of-the-art bespoke Extra Care facility, with a range of accommodation, publicly accessible uses (including a community hall and café), provision of extensive public and private landscaped areas and the erection of a structural deck over a section of the London Underground track. Zack acted for the successful developers at a planning inquiry.
- **Lemon Tree House, Mile End** – Zack succeeded at an inquiry for the Clarion Housing Group, the country's largest social landlord, in an appeal for a 9-storey residential development on Bow Road in Tower Hamlets comprising 100% affordable homes.
- **Holocaust Memorial, Westminster** – a nationally significant Holocaust Memorial and Learning Centre in Victoria Tower Gardens next to the Palace of Westminster. Zack supported this landmark proposal both at a six-week planning inquiry and in the High Court on behalf of "*Learning from the Righteous*", a charity which promotes Holocaust education.

- **Panda House, Tower Hamlets** – a contemporary co-living scheme on the City Road between Canary Wharf and the City of London. Zack appeared at an inquiry for the successful developers.
- **Green Belt appeals** – Zack has appeared for the successful appellants in substantial appeals for Green Belt including Colney Heath, Hertfordshire; Maitland Lodge, Basildon; Sondes Farm, Dorking; Dunton Road, Basildon; Barnet Lane, Borehamwood and others.
- **Ashford Garden Community** – Zack acted for the successful developer of part of the Ashford Garden Community at an inquiry into a 550-home scheme at Kingsnorth to the south of Ashford. The site is within the Stour River Catchment which feeds into Stodmarsh Lakes to the east of Canterbury. So the scheme had to demonstrate nutrient neutrality, which it did by incorporating a wastewater treatment works.
- **Blount Street, Mile End** – Zack acted for the successful developer of a scheme for purpose built student accommodation (PBSA) at an appeal for a site in Tower Hamlets.
- **Extension to Sittingbourne** – Zack secured a major extension to Sittingbourne including 775 homes and a new rugby club in an appeal which was recovered by the Secretary of State.
